## WHAT IS A DONOR-ADVISED FUND?

A donor-advised fund is a charitable investment account just for you, your family or your company. It's an organized, simple, and cost-effective way to manage, grow, and give away charitable contributions. Offering an immediate tax benefit, the fund is invested to grow over time, allowing you to grant distributions to any qualified 501(c)(3) nonprofit organization. Donor-advised funds are the fastest growing charitable vehicle because they are simple, effective and tax-advantaged.

## LOCAL KNOWLEDGE. DEEPER IMPACT.

Our donor-advised funds are provided tailored, hands-on support from a dedicated philanthropic advisor – connecting you to the causes that matter most. Funds receive administrative support, 24/7 online access through our donor portal, tax compliance, grant distribution, and gift recognition processing. Contributions into a donor-advised fund can be made in the form of cash, publicly traded securities, privately held business interests, real estate, and other non-cash assets. You can contribute to your fund at any time, with no minimum requirement, and you can grant distributions from your fund at any time.

## THE CICF COLLABORATIVE OFFERS TWO PRIMARY TYPES OF DONOR-ADVISED FUNDS:

### Standard DAF

- No minimum dollar amount required to open (up to \$25,000)
- No administrative or investment fees
- 24/7 online account access

### Enhanced DAF

- Established with a minimum of \$25,000
- 1% annual administrative fee, assessed 0.25% quarterly, with a minimum annual fee of \$250
- 24/7 online account access
- Investment options (long-term growth, balanced pool, cash/money market, or outside investment manager)
- Personal philanthropic advisor as your staff liaison and go-to expert
- Strategic charitable planning services including mission/purpose development, family engagement, youth philanthropic education, facilitation of family meetings, etc.
- Research, impact, and status reports on grantmaking

The above services and associated fees apply to our standard fund offerings. The CICF Collaborative team can also provide further customized philanthropic advising, fund management and grantmaking services beyond what is outlined here. Please reach out to our staff to discuss additional options.

### Corporate Funds

For businesses, the CICF Collaborative offers corporate-advised funds, which are identical to a donor-advised fund but specific to the philanthropic needs of a business, as a cost-effective, efficient, and meaningful method of organizing company giving and employee engagement.
